100% Guaranteed Loans for SMEs

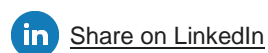
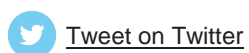
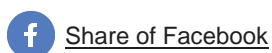
Small businesses will benefit from a new fast-track finance scheme providing loans with a 100% government-backed guarantee for lenders, the Chancellor announced today.

The new Bounce Back Loans scheme, which will provide loans of up to £50,000, would help bolster the existing package of support available to the smallest businesses affected by the coronavirus pandemic.

Businesses will be able to borrow between £2,000 and £50,000 and access the cash within days. Loans will be interest free for the first 12 months, and businesses can apply online through a short and simple form.

The scheme will launch for applications on Monday 4 May. Firms will be able to access these loans through a network of accredited lenders.

Trafford Council encourages eligible companies to submit their grant applications; Trafford Council is calling upon eligible businesses across the borough to apply for their coronavirus grant support funding. Businesses who are yet to apply for the funding need to ensure they register and submit their bank details to the Council as soon as possible.

12 Week Rapid Response Mentoring Programme for SMEs: To assist businesses navigate uncertainty at this time and assist in recovery, Be the Business have introduced a 12 week Rapid Response mentoring programme.

The aim is to help guide SMEs through the crisis, provide them with a sounding board for difficult decisions, and help business owners to develop the most suitable strategy for their business. This will be more of a peer-to-peer support programme as opposed to a long-term mentoring relationship.

About the Rapid Response Mentoring Programme. The programme is intended to be a short, sharp injection of support and will entail:

- 12 week support intervention to deal with acute business challenges
- Suggested weekly calls or online meetings of 1-2 hours
- Rapid matching process with existing registered and available mentors and SMEs

- Accelerated registration process for 'new' mentors and SMEs
- Participation in virtual groups/webinars covering support on relevant topics.

In order to help as many businesses as possible, the eligibility criteria for SMEs has been set at a minimum of £1m+ turnover and 6 full time employees for this cohort. Furloughed workers to receive their full parental leave

entitlement; Furloughed workers planning to take paid parental or adoption leave will be entitled to pay based on their usual earnings rather than a furloughed pay rate, government has announced.

Entitlement to Statutory Maternity Pay, as well as the other forms of Parental or Adoption Pay, are currently calculated through someone's average earnings over an 8-week assessment period. For Maternity Allowance, entitlement and the rate payable is also determined by looking at average earnings over a 13 week period.

The statutory instrument laid in Parliament will ensure workers whose period of family-related pay begins on or after 25 April will be assessed on their usual, full pay. For further information, click [here](#).
